SENATE CONCURRENT RESOLUTION NO. 637

A CONCURRENT RESOLUTION RECOGNIZING THE RECORD OF EFFECTIVE PUBLIC SERVICE OF MISSISSIPPI OIL AND GAS BOARD EXECUTIVE DIRECTOR LISA IVSHIN ON THE OCCASION OF HER RETIREMENT.



WHEREAS, Mississippi Oil and Gas Board Executive Director Lisa Ivshin has announced her retirement after 35 years of effective professional leadership and service to the oil and gas industry in Mississippi and the Gulf South region; and

WHEREAS, prior to her appointment as Executive Director, Lisa served as Deputy Director for Geology and Underground Injection Permits; and

WHEREAS, in 2013, as Chairman of the Interstate Oil and Gas Compact Commission, Governor Phil Bryant commended Lisa Ivshin and requested the federal government to continue the support of state regulatory programs which have been at the forefront of oil and gas exploration since 1935.
