ORDER NO. 450-85ORDER

THIS DAY this cause came on to be heard by the State Oil and Gas Board of Mississippi on the Petition of Exxon Corporation requesting this Board to extend the Special Field Rules for the West Enterprise Field in Amite County, Mississippi for an additional six (6) months, upon proofs of publication of notice and upon oral and documentary evidence introduced at the hearing of this matter, and the Board being of the opinion that the relief sought should be granted as modified herein, does find, as follows, to-wit:

I.

That due, proper and legal notice of the meeting of the Board for the purpose of considering and taking action with respect to said matter has been given in the manner and form provided by law and the Rules and Regulations of this Board and that due, legal and sufficient proofs of publication are on file with the Board, and that the Board has jurisdiction of the subject matter to hear and determine same.

II.

That at the regular April 1985 meeting of this Board, held April 17, 1985, in Docket Number 101-85-642, Petitioner requested that the Board adopt Special Field Rules for West Enterprise Field.

III.

That after hearing the matter this Board, in Order Number 137-85, adopted Special Field Rules for West Enterprise Field but limited the rules to six (6) months. That this Board adopts the testimony, exhibits and other matters associated with the earlier Petition in this matter.

IV.

That additional wells have been drilled and other wells will be drilled within the limits of the field. That since an additional well was recently put on production, there is not the necessary data to have the Special Field Rules made permanent. That there is no data, however, presently available

which would indicate that the producing wells are not draining at least eighty (80) acres.

V.

That an extension of the Special Field Rules for an additional six (6) months would permit additional data to be gathered and are necessary for the protection of the coequal and correlative rights of the owners in the Field and for the prevention of waste.


IT IS, THEREFORE, ORDERED AND ADJUDGED by the State Oil and Gas Board of Mississippi that to promote conservation of oil and gas, safeguard, protect and enforce the coequal and correlative rights of owners in the field, to prevent avoidable waste and to prevent the drilling of unnecessary wells, the Special Field Rules for West Enterprise Field, Amite County, Mississippi, should be and are hereby adopted for an additional period of six (6) months from the date of this Order.

Petitioner shall acquire all other permits, if any, required by any other permitting authority.
